Thank you for your interest in the Santa Maria Cemetery District [SMCD] operations. This letter is responding to the 2005-2006 GJ report, as requested in your correspondence.

The current makeup of the Trustees of the SMCD is vastly different from the time period as cited. However, we do take seriously the criticisms of any agency which has oversight of the district.

It has been a tumultuous time at the SMCD since 5-19-08. At that time, the General Manager effectively quit and the President of the Board resigned. We hired an interim General Manager, two new Trustees were seated [myself included] and shortly after I became Board President. The documentation regarding the difficulties of that era is very scant and sometimes nonexistent. That being said, here is the status of the information you requested:


